- 1. **DELIVERY:** To the address specified above by Lessee (Customer). Lessee grants right to enter the property at the said address ("Delivery Address") for the delivery and subsequent pick up of the unit at the specified time.
- 2. **TRANSPORTATION EXPENSE:** Except as possible herein, all charges in delivering and subsequent pick up of the unit with respect to Delivery Address is included in the Rental Fee noted above. In the event that the unit is not returned at the appointed time by the Lessee to Lessor then a \$100.00 Transportation Fee shall be automatically imposed.
- 3. GENERAL RULES TO FOLLOW DURING USE OF THE UNIT: (a) Only compatible agree groups and size shall play on the unit at the same time. (b) All riders MUST REMOVE SHOES before playing on the Unit. (c) To avoid neck and back injuries, FLIPS ARE NOT ALLOWED. (d) CHILDREN'S SAFTEY DEPENDS UPON YOU. YOUR PERSONAL SUPERVISION IS ABSOLUTELY REQUIRED. AS THE LESSEE OF THE JUMPING CASTLES AND SLIDES CAIRNS UNIT, THE SAFTY OF ALL RIDERS IS YOUR RESPONSIBILITY. (e) Absolutely no "SILLY STRING", GUM CANDY< FOOD or other sticky substances are allowed in the Unit. If upon pick up, such cleaning is required then a \$150.00 cleaning fee shall be automatically imposed. (f) DO NOT MOVE THE JUMPING CASTLES AND SLIDES CAIRNS UNIT from the place where it was installed. If the Unit moves, pull the corner back to its original location of installation. CAUTION: KEEP THE UNIT AWAY FROM SWIMMING POOLS.

The unit is supplied and maintained subject to this warranty. - 9. **TITLE TO:** the lessee agrees to keep the Jumping Castles and Slides Cairns unit in his/her custody not to sublease, rent, sell remove form the delivery address, or otherwise transfer such unit.
